Pre-Meeting Discussions

- 1) There is an issue with logging into the email. Ashley will get the email that coincides with the website working, and then we can just start disregarding the old email. Myssie is sending invite emails directly to Taryn currently.
- 2) Kim gave checks to Sydney for Harlem meet fees and the system/cost location was explained to her. (Inside the trailer there is a list of teams with their meet totals listed.) She has checks for the next three meets. She will write in fees and let Kim know the amount.
- 3) Kim has a room for Sydney reserved in Lewistown at the Yogo. There was concern about her being able to check-in because she isn't 21 yet.
- 4) Liz texted that she wouldn't be at the meeting but something about Hadley needing paid for lifeguard training. We will need numbers when Ryan arrives to complete that transaction.

Coach's Present Meeting

- 1) Taryn is leaving. She will do morning practice and then go to work. There has been no clarification on evening practices. Sydney will cover other practices. Taryn just won't be at the noon practice. Taryn will still make meets that she planned on. Sydney is well prepared to run practice. Focus is technique this week, high yardage for next three weeks, drop yardage prior to divisional for a bit of a rest before really pushing it!

Main Meeting

- 1) STATE Meet
 - a. Everything is rolling with state. Someone is reaching out to Keri about ribbon delivery. .
 - b. Randy Iverson was approached about power.
 - c. 4-30 amp outlets
 - i. Some vendors will need to use their generators possibly.
 - d. Put out there that donations are needed for the items we are selling out of concessions.
 - i. Water, Gator-ade
 - ii. Stuff for timers and stroke judges
 - 1. Talk to Lorilee about what is needed there.
- 2) Treasurer's Report
 - a. Generic printout for meeting.
 - i. \$90.75 check to bring up scholarship fee and short payments from 2022 season.
 - ii. Ella is our swimmer who qualifies as potential recipient of scholarship.
 - b. Things are starting to get setup in Wave.
 - c. Torrey needs to contact someone about receiving TBID money.
 - d. Sydney will get a check Thursday or Friday for two weeks practice and one meet.
 - i. 1350.00

- ii. Ashley made a motion to pay Sydney today. Jeri seconded the motion. All approved. Motion carried.
- iii. Taryn.....do we want to adjust her pay?
 - Ashley brought up that she is still technically doing what she was going to. Ashley made a motion to approve keeping her original pay. Suzann asked for more discussion and clarification. Suzann seconded. All approved.
 - a. This can be readdressed down the road if it seems she isn't fulfilling her original duties as expected.
- 3) Unfinished Business
 - a. Headsets are still sitting at customs in California. If they arrive when Ashley is gone, Taryn can go pick them up.
 - Can we put the setup that Mike uses for the headsets in the Concessions area? Concern about having access to that room. Make Tonya aware that we would prefer people out of it. When they arrive, we will address location of them more.
 - b. Trailer insurance licensed under Sidney Tiger Sharks. It is virtually impossible to insure it under an organization and not a person. No one wants to be liable for a trailer that is being driven by someone else. Whoever is pulling it, make sure they have towing coverage. Most policies with full coverage should cover this. Keep those who tow it to a minimum.
 - i. Homeowners insurance should cover if anything happens to the trailer when it is parked at Radke's.
 - ii. Kim mentioned that a vehicle towing multiple items damage won't be covered by policy if the trailer is **not** connected directly to the vehicle.
 - iii. People towing the trailer will sign a release to cover potential issues. Ashley will write this.
 - c. Website
 - i. Ashley has the website live.
 - 1. sidneytigersharks.com
 - 2. Ashley discussed running email through this website. Since there are so many issues with Gmail account, can we just run the email through this website. When people leave the board, the password can be changed. Do we want multiple email addresses for individual parties? No. One email. Things can be doled out to necessary recipients. The website is registered to Ashley, so if she leaves the board, someone else will need to take that over. Someone else needs to be admin...Jackie offered.
