 - a. State Meet

- vi. Jared mentioned he has an issue with Tonya. Taryn mentioned that Tonya will likely step back and let him do his thing.
- vii. Thank you to those who took the time to interview him.
- viii. He was told we have people in place for "assistant".
- ix. Torrey made a motion to hire Ryan Payne as head coach.
- x. Lorilee seconded the motion.

- xii. Base salary = \$6000 and mileage, .50/mile, \$50/day, and hotel he can book his own hotel he's an adult.
